Institutional Effectiveness Committee

Purpose & Purview

The committee's charge is as follows:

The Institutional Effectiveness Committee (IEC) serves to promote ongoing and continuous improvement through the evaluation and assessment of college processes that supports the college mission. The IEC reports to the Mission Informed Planning Council (MIPC).

Some of the committee's responsibilities include:

- Assessing institutional-level planning documents (e.g. Educational Master Plan, Facilities Master Plan, Student Equity Plan, Technology Plan, etc.)
- Facilitating discussion about institutional-level initiatives, efforts (e.g. Guided Pathways, Vision Aligned Reporting, Program Review, etc.)
- Promoting program coordination and collaboration efforts
- Focusing on continuous improvement in assessment, planning, student learning
- Supporting integrated systemic efforts in a participatory governance environment.

The student liaison role includes:

- Meeting regularly with the IEC chair (Elaine Quo), approximately 2 times a quarter
- Sharing out IEC updates with ASFC (e.g. at the end of each quarter)
- Ask questions to ensure the IEC's work is lifting and centering around students
- Optional (but encouraged): Attending the IEC meetings (October 31, 2024 @ 10am; December 5, 2024 @ 11am; we are hoping to schedule monthly meetings in winter and spring quarters).
