- 3. Agenda was approved by consensus. Minutes from the November 2<sup>nd</sup> meeting were corrected for spelling of Alexis Aguilar's name, and also adopted by consensus.
- 4. There was no public comment.
- 5. The consent calendar (<u>Senate appointments</u>) was amended and approved by consensus. Kathryn mentioned the deadline nearing to find a few more at large readers of Program Review, which is now on a 5 year cycle.
- 6. Robert Cormia, Academic Senate Secretary Treasurer, presented budget updates:

Current Academic Senate balance \$10,655, ~ \$3,900 dues expected through the end of the year

~ \$5,000 income from dues (10 months x \$485/month)

Expected expenses through June 30, 2021

\$4,500 P/T AS reps (\$750 per quarter x 2 reps x 3 quarters) \$600 ASCCC plenary expenses

Typical budget (pre COVID):

\$5,000 Senate dues (F, W, S)

There will be further discussions about the Senate budget.

7. David Marasco talked about scholarships in the range of \$2,500 - \$3000 per year. Big scholarships of \$1,000 per category (\$500 per student for 2 students in each category) were awarded to workforce, transfer, and basic skills, but AB705 has impacted these categories. Scholarships at \$500 or \$250 might also be offered.

We're not sure about the status of scholarships from last year, and Robert Cormia will check with Robin Latta at FHDA Foundation to see if we have a balance with scholarships. A question was asked about moving forward with \$2,000 in scholarships; senators will ask division faculty about continuing to offer scholarships, and specifically at the \$2,500 to \$3000 level.

Cormia asked what other funding is available to students? Donna suggested our scholarships should fill needs not being met already.
