Who we are, and why we're here

The Academic Senate is the body which...

- performs "the faculty" role & responsibility in higher education to establish standards & procedures for academic & professional matters (the 10+1)
- 2. represents faculty (all full and part-time faculty) in institutional decision-making (shared governance)

The Foothill College Academic Senate



- All full and part-time faculty are members of the academic senate
 - Roles & responsibilities of <u>all faculty</u> stay informed, serve on governance/committees
- Representational senate: each "division" elects 1-2 voting "senators"; PT faculty elect 2 At-Large PT senators
- Executive Committee = senators + officers + "other" voting & non-voting members
 (New for 2021-22!)


Executive Committee Members' Roles & Responsibilities

- Attend senate meetings (regular & special)
 - Prepare, participate, move items, vote
- Represent constituents
 - Communicate timely, solicit feedback, present at division meetings, etc.
 - Vote will of constituents
- Bring forward 10+1 items to officers
- Author senate resolutions
- Participate in governance, committees, study groups
- 2-year term



Academic Senates in Ed Code ("the law") and Regulations (Title 5)

- -AB 1725 (1988)
- Education Code §70902 (b)(7)

Academic Senates in Ed Code ("the law") and Regulations (Title 5)

- California Code of Regulations (Title 5 §53203)
 - Powers of the Academic Senate
 - Make policy through collegial consultation, can appear before the board
 - Definitions
 - What are the "academic & professional matters" the board shall rely on an academic senate for policy setting & implementation (the "10+1" + others)



Title 5 §53200 (c): DefinitionsThe "10+1"

- Curriculum including establishing prerequisites and placing courses within disciplines
- 2. Degree and certificate requirements
- 3. Grading policies
- 4. Educational program development
- 5. Standards or policies regarding student preparation and success
- 6. District and college governance structures, as related to faculty roles

- 7. Faculty roles and involvement in accreditation processes, including self-study and annual reports
- 8. Policies for faculty professional development activities
- 9. Processes for program review
- Processes for institutional planning and budget development
- 11. Other academic and professional matters as mutually agreed upon between the governing board and the academic senate

- The Board of Governors relies primarily upon the advice and judgement of the ASCCC in academic and professional matters.

Understanding Collegial Consultation

Joint Development (Mutually Agree)

Existing policy shall remain in effect except in cases of legal liability or fiscal hardship. Board may act, after a good faith effort to reach agreement, only for compelling legal, fiscal, or organizational reasons.

Primary Reliance

the recommendations of the senate will normally be accepted, and only in exceptional circumstances and for compelling reasons will the recommendations not be accepted. If a recommendation is not accepted, the governing board or its designee, upon request of the academic senate, shall promptly communicate its reasons in writing to the academic senate.



- Other academic & professional issues

- "Collegial Consultation" = between the Board (or delegate) & the Academic Senate
- In Title V, ACCJC & FHDA Board Policy (BPs2222 & 2224) "effective participation" of staff and students

Student Roles in College Governance "The 9+1"



Board shall not take action on a matter having a significant effect on students until recommendations and positions by students are given every reasonable consideration.


- (1) grading polices
- (2) codes of student conduct
- (3) academic disciplinary policies
- (4) curriculum development
- (5) courses or programs which should be initiated or discontinued
- (6) processes for institutional planning and budget development
- (7) standards and polices regarding student preparation and success
- (8) student services planning and development
- (9) student fees within the authority of the district to adopt


Title 5 §51023.7

(10) any other district and college policy, procedure or related matter that the district governing board determines will have a significant effect on students

Other "duties" of academic senates


- Establish minimum qualifications for faculty
- Appoint faculty to serve on governance councils/committees & hiring committees
- Approve faculty & tenure evaluation processes & FSA's prior to negotiation

Subcommittees of the Academic Senate

- College Curriculum Committee (CCC) fully autonomous
 - Expectation: mirror representation on the Executive Committee
- Committee on Online Learning (COOL)
 - makes recommendations to the Executive Committee for consideration
- -Other???

Brown Act (1953)

- Prohibits "Secret Meetings" of government bodies
- Key Points
 - Agenda must be posted 72 hours before meeting
 - No action may be taken on items not on agenda
 - Items must include description (20 words max)
 - Public comment



Parliamentary Procedure ("Robert's Rules")

- "Set of rules that allow everyone to be heard and to make decisions with minimal confusion."
- Order of Business
- Discussions
- Motions
 - Propose, Second, Amend
- Resolutions
- Voting

Academic Senate Budget

- Types of Expenses
 - Paid directly by us:
 - ASCCC Plenary (now ~ \$1,000-\$3,000/ yr)
 - Scholarships (~\$2,500 / yr)
 - PT senator stipends (~\$4,250 / yr)
 - Paid by the college
 - Reassign time for officers
 - Membership in ASCCC
 - Additional conference expenses
 - New for 2021-22: PT senator stipends
- Internal Source of Funding = Faculty dues
