The feedback from last week Agentic AI: faculty are outraged, scared, overwhelmed or rethinking teaching online asynchronous. Job security concerns, and how much should faculty be using it in their classes?

Lené--we can support by bringing in Rumi, Harmonize, more synchronous or hybrid software. We should rethink our strategies for scheduling modality. We need to train faculty on modalities.

Paula, attended a Nectir webinar.—she will share the webinar that looks at AI in a hopeful way.

Allison—shared letter draft for asking for collaboration, support, because of Agent AI. We need to have a coordinated effort. We need an AI coordinator or was there going to be a manager in administration who would be to support AI fellows?

Kas/Amber, add AP 1405—use existing policies in the letter even if not working. Recommend having someone from each division serve as fellows.

Carolyn—ask President Whalen to create a position and identify problems with AI. However, professional development requests should be separate.

Helen: Let's suggest Jory collaborate with other colleges/CVC so we're leveraging the power of the system with Instructure. Not just one college at a time.

Allison calls for a vote on the letter.

Sally suggests that we separate the requests into two letters. Several agreed.

Allison showed two slides summarizing the AI landscape on campus, four areas, College Wide AI policies, Pedagogy, Community implications Professional development. There doesn't seem to be a clear area for students and faculty who are refuse to use AI. Informed Refusal.

SuQiong, also wants to ask President Whalen if we have a coordinator for AI fellow rather than assuming administration does it? And she states that all views for AI should be included in the slide.

Dr. Pia Staana, informed refusal is used and HSH, and should be included.

Allison,— We will break the request into two letters: one for AI Agent AI to Jory and then a second for the fellows/coordinator.

Majority agree we separate and send the letters to the Senate for feedback. Doing it today.
