#### 1. Land Acknowledgement: Approval of February 10<sup>th</sup> & January 27<sup>th</sup> Meeting Minutes:

#### 2. Governance Recap: Ideas on How to Develop Mission Based Shared Governance Structure

- CS reviewed the slides from February 10<sup>th</sup> presented by CS President, Adrienne. There
  was an update to the membership slide, where the President was listed as "given" by the
  taskforce to be at the table of the mission-based shared governance structure. Instead of
  the President representing Administration and maybe as a facilitator, the update would be
  the President represents the college.
  - Some members agreed to having the College President as the representative of the college and be present at the table of the one council. Here are some reasons mentioned: (1) All administrators report to the President (2) If we look at the one council model as advisory to the President, it might make sense to have them facilitate and decide based on those advice.

- Some members questioned about what would that facilitator role look like for the President? Would the voice of the Administration be lost? What about voting? If we move towards a mission-based governance structure, then what does that space look like for CS?
- Some members were concerned about having the President present at the table.
   Based on experiences from the last governance structure, there could be challenges with having the President present and knowingly or unknowingly sway any advisory discussion to agree with their stand.
- There was a discussion about putting together guiding principles for the President in the governance space. CS members agreed including something about trust transparency, etc.
- CS recap on the mission and the highlighted topics that the taskforce saw as major areas that makes up the purpose of the college. Members shared their thoughts on what could be missing that the six areas don't cover.
  - Which of the six covers student success and not just academics?

- Members reviewed the notes from the January meeting where CS tackled the mission and purpose of Foothill College's Classified Senate. Updates & Clarification discussed:
