What is Equity 3.0 <u>and</u> why is it important to us?

- The Student Equity and Achievement Program funds activities and practices in California Community Colleges aimed at closing achievement gaps for underrepresented students and promoting success for all students.
- To receive these funds,
 - (1) college-wide student equity plan,
 - (2) provide matriculation services,
 - (3) adopt equitable placement policies, and
 - (4) ensure all students receive an educational plan.

Spotlight – NextUp & Foster Youth

NextUp's reach-in model delivers coordinated support across admissions, financial aid, and basic needs. To help African American and Latiné students better access first-tier priority registration, the program will intensify targeted outreach and expand flexible appointments so students stay on track and maintain momentum.

Spotlight – MANAPUA

Promising Practice: The core focus areas of MANAPUA include academic support, leadership development, mental health and wellness engagement, culturally relevant learning, and career readiness. Through the active engagement of mentorship, as well as developing a community of learning for the mentees, we look to provide high-impact direct student support. An intentionally developed community of learning for the mentors will also allow for greater institutional support, allowing for sharing best practices and discussing possible challenges.
