Elaine Kuo presented the onboarding and training session to the Institutional Effectiveness			
Committee (IEC), with the primary goal of introducing the committee and establishing a			
framework to support college-level planning, initiatives, and accreditation. The IEC is a new			
advisory committee designed to drive continuous improvement efforts that align with the			
college's mission. The committee's main focus will be on facilitating discussions about institu-			
tional improvements, supporting the assessment and evaluation of institutional plans and ini-			
tiatives for effectiveness, and promoting cross-college dialogue. Additionally, the IEC will			
evaluate and assess college processes in a way that supports the advancement of institu-			
tional quality and overall mission. The committee will play a vital role in supporting inte-			
grated planning, communicating institutional progress toward its goals, and making recom-			
mendations to the Mission Informed Planning Council (MIPC).			
The membership of the IEC will include four administrators, two faculty members, two staff			
members, a facilitator, a recorder, and a student liaison (to be appointed by ASFC). Commit-			
tee members will serve two-year terms. This year, the committee has several key objectives:			
establishing an 8-year planning calendar for institutional activities, documenting existing col-			
lege-level plans and initiatives supporting program review discussions assisting with govern-			

lege-level plans and initiatives, supporting program review discussions, assisting with governance evaluation, and contributing to accreditation preparation and ongoing efforts. The committee's work is aligned with the state's Vision 2030 goals, which emphasize equity, success, access, and support, and the Educational Master Plan.

The committee discussed its operational procedures and agreed on a set of guiding principles. These include using consensus for decision-making whenever possible, with voting as a



backup option, trusting the iterative process as the committee's role evolves, being present and contributing unique perspectives, and remaining open to new ideas and approaches. During the fall and winter quarters, the committee will begin receiving updates on collegelevel planning documents, which will help inform the development of the 8-year planning calendar. A comment was made regarding the need to clearly define what constitutes a "planning document" or "initiative," given the number of ongoing efforts across campus. Clarifying these terms will help the committee determine what should be included in the planning calendar and what needs to be reported out. Further discussions on refining these definitions and finalizing the list of planning documents and initiatives will take place in upcoming meetings.

The committee also reviewed the update template for tracking progress on planning documents. Members provided feedback on the template, and those suggestions will be incorporated into the final version.
