Enrollment

- o Resident student headcount is flat while Non-Resident counts are up 9%.
- o Resident and Non-Resident FTES are both down with Non-Resident down 9%.
- o Overall, student headcount increased 188, which is a 1% increase.
- Overall, estimated FTES increased by 14, which is less than 1%--so change in FTES is flat.

• International (F1) Students

- Headcount among Fall 2017 F1/FC students is 911, a decline of 9% from Fall 2016 (1,004).
- Male students represent more than half of the F1/FC enrollment (57%), a 3% increase from Fall 2016.
- o Female F1/FC students declined by 14% from Fall 2016 to Fall 2017 (452 to 390).
- China (F17: 363; F16: 388), Japan (F17: 77; F16: 79), and Hong Kong (F17: 75; F16: 81) represent the top three places of origin in Fall 2017 and Fall 2016.
 Together these three represent 57% of F1/FC student enrollment in Fall 2017.

Student Ethnicity

- Headcount among Filipinx (-51) and Pacific Islander (-26) students declined between Fall 2016 and Fall 2017.
- Headcount among African American (+14), Asian (+215), Latinx (+189), and
 White (+62) students increased between Fall 2016 and Fall 2017.

- Student Population Type: Non-Residents
 - Non-Residents who are first-time new (-28) and continuing (-51) saw a decrease in headcount.
 - Continuing students represent the largest group among non-residents (Fall 2017: 45%; Fall 2016: 52%).
 - Overall, non-resident headcount increased by 148 (-9%), and their estimated FTES decreased by 7 (-1%). More non-residents enrolled in Fall 2017 compared to Fall 2016, yet non-residents enrolled in fewer courses this fall.

• Zip Code Grouping

- Within Santa Clara County, headcount increased by 138 students from Fall 2016 and Fall 2017, representing a 4% increase.
- o The largest percentage decline in student headcount was from "San Jose East of 880, Alviso, Milpitas, Fremont, Union City, Newark, Hayward, East Palo Alto" (-6%).
- Headcount from "All Other Areas" increased by 293 students or 11% from Fall 2016 compared to Fall 2017.

- Zip Code Grouping as Percent of Total Enrollment
 - As a percentage of total headcount, students from the immediate service area (Cupertino, Sunnyvale, Los Altos, Mountain View, Palo Alto, Los Gatos, Saratoga) and from "San Jose East of 880, Alviso, Milpitas, Fremont, Union City, Newark, Hayward, East Palo Alto," represent over half of all enrolled students (56%).
 - As a percentage of total headcount, students enrolled from Santa Clara County increased 1% (Fall 2017: 27%; Fall 2016: 26%).

- Zip Code Grouping within Santa Clara County
 - African American (194 to 191), Filipinx (392 to 373), and Latinx (1,241 to 1,231) all experienced a headcount decrease among those from "San Jose East of 880, Alviso, Milpitas, Fremont, Union City, Newark, Hayward, East Palo Alto."
 - The Latinx student population experienced the largest headcount increase (+115) compared to African Americans (+10) and Filipinx (-25).
 - Almost three-fourths of Filipinx students reside within Santa Clara County (Fall 2017: 72%; Fall 2016: 70%) compared to less than two-thirds among African American students (Fall 2017 and Fall 2016: 59%).
