**ITEM I**

**FTE REQUESTS – SURVEY RESULTS – Davison**

Starer – Was concerned that not enough people voted, recommended that we should postpone decision on positions to go forward. Felt it was also important that the President be able to hear the discussion.

The question was raised as to why the process did not work as efficiently this time as it did last go round?

Consensus was that there was not enough time for everyone to participate due to work loads and time constraints with Banner training.

Was also mentioned that the timeline was just generally too short for thorough response.

Barker – thanked those who did NOT vote because they didn't have time – it was assurance that everyone was taking the process very seriously and chose not to participate rather than doing so in a less than thorough manner.

Noted that it was again interesting that the split was clearly the top 6 and large jump to position 7. She further noted that there are changes that could occur in positions below the top votes that would also suggest we wait.

Davision – noted that one position also didn't have backup information

Mostafa – suggested that the committee study, discuss and then vote in an open forum.

Starter – don't want to use extra time unless we are educating them so they can vote with high degree of confidence – takes a lot of time to go through 14 proposals perhaps do in smaller groups.

After lengthy discussion, it was decided that the survey would be sent out again and the timeline for response would be extended to May 14. It will also be on the next PaRC agenda to continue discussion.

## **ITEM II**

### ACCREDITATION UPDATE – Gilani for Hueg

Gilani – announced that the accreditation workshop would be Friday, April 23. The website is up and running - be sure to check it out

Davison – announced that the State Academic Senate at the recent meeting, voted to move forward with a request to ACCJC that asked for more open processes. ACCJC responded they didn't respond to individual requests and that the Senate needed to go through their college. The senate responded with a resolution including a vote of "no confidence" if the concerns were not addressed or discussed.

### QUESTIONS/RUMORS – Davison

Gallagher – Banner basic training is being planned for entire community.

Olsen – suggested it would be good to have a list of the "go to" people for questions and concerns.

Starter – suggested that Banner be presented to the PaRC committee so that they could be more familiar with its new challenges and processes. He will let Annette know who the presenter will be and will then be on future PaRC agenda.
