## **GENERAL EDUCATION REVIEW Deadlines and Instructions**

After ratification of the revised FH General Education criteria, the CCC came to the following decisions to transition fully to the new criteria:

1. All courses on the 2009-10 GE list will remain for the 09-10 & 10-11 year.
2. The CCC will accept applications for **NEW** courses to be added to GE for the 2010-11 year (using the revised criteria). These applications are due no later than **October 15, 2009**.
3. The CCC will accept applications for **EXISTING** courses, new to GE, for the 2010-11 year (using the revised criteria) due no later than **December 4, 2009**.
4. The 2010-11 GE List will include the old courses and the new, approved courses based on the new criteria.
5. Any course on the 2009-10 GE List that wishes to remain on the 2011-12 List **MUST** reapply by the following review deadlines:

### **Application Information:**

1. Applications must be approved by Division Curriculum Committee and filed with the Curriculum Assistant for CCC Agenda inclusion on the date listed.
2. **Get your application in early!** The committee will only guarantee review of the first **20** applications for each successive review. Additional applications will be reviewed, time permitting.
3. Please turn in the applications to the **Curriculum Coordinator**. They will then be distributed to the appropriate GE Sub-Committee.
