5. Minimum Competencies Resolution	Speaker: Carolyn Holcroft <p>First read. Thank you Kathy Armstrong for preparing resolution based on the previous discussions regarding GE for Certificate of Achievements. Gather feedback from constituents, will be an action item on next agenda.</p>
6. Families of Courses <ul style="list-style-type: none"> a. Kinesiology & Athletics b. Fine Arts 	Speaker: Barbara Shewfelt, Don MacNeil, Simon Pennington, Robert Hartwell, Hilary Gomes, Tom Gough, Janis Stevenson <ul style="list-style-type: none"> a. Shewfelt explained their "family designations". The recommendation of CCC is to reassess the number of families that have been created by the division faculty. CCC feels that there is danger in creating too many different families, particularly the fragmentation of dance and fitness. b. FH faculty met with the DA faculty and discussed the family creations at great length. <p>Music-(see attached list) Although the offshoots of some of the guitar courses are unlimited, Stevenson requested that the record state that trying to accomplish a full degree in that limited number of courses is very difficult. M/S (Hanning, Murray) to accept the families as written. Approved.</p>

	<p>Photography-(see attached list) Faculty looked to AA degree and the TMC organization as guides. Clarification was requested regarding the section that reads "exempt": It was explained that those courses are not activity courses and therefore it's not necessary for them to be in a "family" but the faculty wanted to make it clear that they had reviewed those courses in their deliberations. M/S (Starer, Murray) to accept the families as written. Approved.</p> <p>Art- (see attached list)</p> <ul style="list-style-type: none"> • Question about need for two ceramics families. Gomes clarified that ceramic surfacing refers to the chemical make up and running a kiln and therefore two families reasonable. Split is similar to distinction between two families in theatre - one for performance and one for production. • It was suggested that the ceramics lab courses be incorporated into the parent course rather than continue as separate courses (makes one class out of six potential takes instead of two). • ART 4G will be moved to Painting and after discussion the committee suggested that ART 72 should be exempt as it does not appear to meet the criteria for "activity course". <p>M/S (Pennington, Starer) to accept the families as written. Approved.</p> <p>Theatre-(see attached list) The suggestion was made to change the title of the Voice family to "Voice for Theatre" or something more descriptive to distinguish it from the voice family in music. Resolved, that the faculty discipline experts for each certificate of achievement program consult with math and English faculty to determine the appropriate minimum math and English competencies, if any, for their certificate program; and,

Resolved, that as of March 3, 2013, each certificate of achievement program sheet must include a statement specifically addressing the presence or absence of mathematics and English minimum competency requirements, and that our catalog be modified to clarify the requirement(s) for each certificate of achievement program.

Whereas, student mobility is common due to course reductions and personal impediments-necessitating breaks in enrollment or attendance at other institutions;

Whereas, continuous enrollment is not required for the application of previously approved IGETC, CSU GE, reciprocity agreements, or pass-along courses from other institutions toward satisfaction of the Foothill General Education requirements;

Whereas, requiring students to complete additional General Education courses solely on the basis of non-continuous enrollment results in unnecessary repetition of classes and increases college costs;

Resolved, that Foothill College eliminate barriers for students to earning an associate's degree by permitting the application of approved Foothill General Education courses without the requirement of continuous enrollment.
