Paul Davies highlighted some of the actions taken by the music department in its effort to meet the ADT in music. In particular, the addition of a new music theory class (MUS 3D) will align the Foothill theory offerings with the ADT. Hartwell mentioned that other areas (e.g., studio instruction) remain problematic, i.e., individual instrumental instruction is wholly at odds with prevailing budgetary constraints. He also noted that the current ADT will likely undergo revision. A resolution by the State Academic Senate calls for revisions; changes are clearly needed, as only a few of California's 113 community colleges are able to meet the present requirements.
