1. Minutes: February 16, 2010	Minutes approved as written. M/S/C (Schultz, Pennington) 1 abstention
2. Curriculum Changes for 2010-11	Speaker: Cori Nunez Presented the curriculum changes that have occurred from December through February for the 2010-11 Catalog.
3. C-ID Presentation & High School Articulation	Speaker: Bernie Day Day informed the committee that at the next meeting we will have a visitor to speak to us about C-ID and Statewide Career Pathways program, Michelle Pilati, ASCCC Vice President and faculty coordinator for the C-ID and the Statewide Career Pathways projects. C-ID is a “super” number system. The students won’t necessarily see these numbers but the colleges will have use of them. The projects goal is to provide course qualification that relies on intersegmental faculty expertise. The project has a web portal that provides a place and time where interdisciplinary faculty can come together to decide what elements should be in a particular course. UC has not determined if they will participate in C-ID. It is designed to be a one-way transferable system not two-way articulation. Encourage your faculty to look at the descriptors on the website: www.c-id.net Community college faculty need to participate so that the final descriptors reflect CCC needs not just the CSU faculty “wants”. Statewide Career Pathways: SB 70 mandated. State wants community colleges to articulate some high schools courses to FH so that students can move quicker/smoothier through their program or transfer intentions here. Tech Prep courses come from the high schools to us. It is up to our institution how and what will be accepted. It might not be appropriate for every department. Could be it’s only for Tech/vocational courses. High School Course Articulation: 1) college credit awarded based on student performance and 2) Credit by Exam: awarded credit based on student’s exam.
4. Disciplines List Review	Speaker: Carolyn Holcroft The Minimum Qualifications list is maintained by the State Academic Senate and reviewed every two years. It is currently the beginning of the next two-year cycle. In collaboration with the other faculty in your division, please review definitions of the areas that are germane for your disciplines to determine if you think there need to be any revisions or if a new discipline should be added to the list. If you wish to suggest revisions/additions, please complete the proposal form (attached to agenda) and send it to Holcroft (contact Holcroft if you need assistance completing the form). This is an especially important time in that the disciplines on the list are tied to FSAs which have become important recently as RIF’ing might be in our future. March 16 th due date for feedback to Holcroft regarding possible new proposals.
