Reminder to please ask your faculty to continue to review the list. We have until the Fall Plenary to get them in but best to bring suggested revisions to the Spring 2010 State Academic Senate Plenary session if at all possible.</p> <p>b. SLOs must be on your green sheets. Very important for Accreditation. Reps expressed concerns regarding the amount of info that represents the SLOs for a course: couldn't it be a url that the student could refer to as they are interested? Orrell answered that this would be possible. Faculty are strongly encouraged to add SLOs to green sheets as of Spring quarter, but they <b>must</b> be added no later than Fall 2010. Suggested that there be something sent out regarding SLO's to give direction.</p> <p>c. Accreditation guidelines require us to complete a Program Review for the Foothill GE Pattern as well as our transfer program. Holcroft will coordinate. Sauter will assist. Michelle Pilati, Vice President ASCCC                                 | <p><b>Speaker: Bernie Day (intro) Michelle Pilati</b></p> <ul style="list-style-type: none"> <li>Why should we care about what's going on at the State level? The legislators see faculty as the "Party of No". They are entertaining mandating things rather than giving faculty the power to make decisions. They are questioning our mission. We need to identify how to work together collegially to create some ideas regarding transferability rather than wait until things are mandated at the State level.</li> <li>C-ID is the new vision of CAN. This system is intended to facilitate the articulation process. This will hopefully make it much easier for students to move between numerous comm. colleges. Descriptors are currently online for review in many disciplines, but those in Accounting, Sociology, Communication Studies and History will be processed first. Once these have finalized descriptors they will be presented to the UC's/CSU's to see if they will articulate appropriate courses. First and foremost, the point is to identify courses that can obviously transfer. This system is going to possibly have 2 types of similar courses e.g. ECON with math prereq and ECON with no math prereqs. The State has said that they would be willing to support regional area meetings to accommodate this work as they are trying to move as quickly as possible. There isn't a clear schedule as getting participation going with UC's has been slow coming.</li> <li>Why should we participate? |   | <p>accept them as transferable due to the amount of work that had been provided under the old system.</p> <ul style="list-style-type: none"><li>• Career Pathways - Why would we do this? How do the students get credit? Articulation agreements give the high school specific guidelines about what needs to be in the course. Must have Credit by Exam in order to get the CC transfer credit. In some cases, we may choose not to award credit but instead use the high school course to satisfy a prereq for our (community college) course.</li><li>• We need to publish a Credit by Exam list.</li><li>• Transfer Degrees- AB 1440 proposes to mandate that we offer a transfer degree and that such degree must waive the local degree requirements. All the courses must be transferable courses. Rather than letting this become legislation, State Academic Senate exploring possible Title 5 change instead. Please take time to review the proposed resolutions sent to you by Holcroft last Friday.</li><li>• CSU, in cooperation with Carnegie Foundation, is having a symposium to talk about students needs in the future. We have been invited to attend on their dime, May 3<sup>rd</sup> &amp; 4<sup>th</sup> 2010. Possibly IGETC &amp; CSU GE rolled into one? "What constitutes a baccalaureate course" is being looked at.
